"Thank you also to our witnesses today. The corruption going on behind USAID's doors has been a wakeup call for all

Americans.

As Chairman of the House Homeland Security Committee, I spent the last two years exposing the Biden administration's sabotage of our border and the policies that kept America safe. I saw firsthand their willful refusal to protect this country. Under the guise of "foreign aid," USAID has been an unapologetic front for a far-left agenda. It has become self-evident these weren't a handful of foolish policies but rather a coordinated strategy of radical, idiotic, and often anti-American priorities.

Idiotic, you say? Millions to teach Moroccans how to make pottery? The Moroccans were making pottery before we were a country!

This entire debate today and the crocodile tears from Democrats just goes to show what is wrong with this town. Not a single Democrat I have heard has expressed dismay over the many examples of crazy, wasteful spending. I don't understand the objection to a deep dive in how we spend our money. But perhaps it's the fact that over the last several weeks, a massive surge has occurred in the search for a criminal defense attorney. That probably says it all! It's up five times in this city, more than any other city in the nation. I would like to remind this Committee that President Kennedy unilaterally created USAID through an executive order in 1961.
